Position of the course

This course aims to give students an introduction to the field of policy sciences and its main

branches with a particular focus on policy process theories. It helps them better approach (understand, explain, and basically assess) public policy from a scientific perspective. In this course, we explore how the world of public policy works and provide an overview of how policies are formulated, implemented, and evaluated.

Contents

This course uses real life cases and examples from everyday life to achieve its objectives. The course comprises three main sections.

The first section provides learners with a basic scientific understanding of key concepts. This includes what government is, what policy is, the core components, principles and objectives of policy research and practice, and some central dynamics of policymaking.

The second section provides learners with a nuanced understanding of the different stages of the policy process (i.e., agenda-setting, policy formulation, decision-making, policy implementation, policy evaluation). It also helps learners understand how these stages are observed in real life situations. In this section, learners also get a glimpse of how different theories of the policy process study policymaking in contemporary settings.

The last section of this course provides learners with an overview of emerging trends in policy sciences over recent years such as evidence-based policymaking, design thinking, and policy labs among others.

Throughout this course, we will be using a series of examples and case studies to ensure that learners get an in-depth and practical understanding of concepts discussed. For example, this includes discussions and reflections on how policy concepts and theories can be observed in pressing issues such as climate change, sustainable development, and sustainability transitions. This is in addition to understanding how such central issues are connected to other policy domains such as transport policy, health policy, and international relations. In doing so, this course aims to give learners a basic yet nuanced understanding of the interconnectedness and of real-life public policy issues and how are they approached from a policy theory perspective.
